## INSTRUCTIONS

### TO THE APPLICANT

You must supply written documentation of the facts when filing this application:

1. You shall provide evidence that the vehicle is currently licensed under the authority of the Highway Traffic Act.
2. You shall provide evidence that the vehicle is mechanically fit.
3. You are required to submit a letter of agreement with an insurance company stating the following:
  - a) they will insure you for an amount not less than \$1,000,000.00 if your licence is granted; and
  - b) they will endorse the policy agreeing to advise the Sault Ste. Marie Police Service of any change or cancellation of the policy within 48 hours of the change or cancellation occurring.
4. You may be required to file any other such document as may be required by the Chief of Police.

If your application is approved, it is with the understanding that you will comply with all conditions set forth in this application and in the documentation filed with this application. Failure to comply with the information contained in your application may result in your licence being revoked.
